Jessie Ball duPont Fund



Jessie Ball duPont was a woman of compassion, courage, independent spirit and business savvy. These qualities were evident long before her marriage to Alfred I. duPont and, long after his death, they enabled her to become one of the leading female philanthropists in the American South.

She was born Jessie Dew Ball in 1884, into a genteel Virginia family impoverished by the Civil War. She pursued her education with diligence, first in a one-room country school and later in what is now Longwood University in Farmville, Virginia. In the 1890s, when barely a teenager, she assisted her father in his law practice, riding alone throughout the county to pay his bills and collect his legal fees.

She taught school for a while in her home county but, seeing limited opportunities in rural Virginia, she moved herself and her parents to San Diego, California in 1908. There she became assistant principal in the largest elementary school in the city.

By 1915 she was investing her modest savings in California real estate. Two years later, she traveled alone to Alaska, "almost unheard of for an unescorted woman at that time," writes her biographer, Richard Greening Hewlett.

It was in San Diego during this period that she first demonstrated her philanthropic tendencies. Jessie began awarding college scholarships to needy students, eventually managing more than 100 such scholarships, a reflection early in life of her deep commitment to education.

"She seemed determined to create her own definition of womanhood," writes Hewlett, "that would reflect her upbringing as a product of southern gentility and her awareness that women could succeed at intellectual and business activities as well as men."

In 1921, she married Alfred I. duPont, who was 20 years her elder. They had first met decades earlier, when Alfred came to Virginia on hunting expeditions. Jessie had fallen passionately in love with him, but the detours of life had kept them apart.

Throughout their marriage, Jessie not only was a devoted wife but a constant companion and close advisor to her husband in both his business and charitable activities. When he died in 1935, she assumed control of his vast business enterprises in Florida and became the principal trustee of his estate. In his memory, she created three foundations: one to build a children's hospital in Delaware (the Nemours Foundation), a second to assist needy persons in Florida, Delaware and Virginia (the Alfred I. duPont Foundation), and a third to recognize outstanding contributions in the field of broadcast journalism (the Alfred I. duPont Awards Foundation).

For the remainder of her life, Jessie focused on her charitable and philanthropic work. She funded hundreds of scholarships for college students, mostly in the southeastern states. Her gifts to colleges and universities augmented faculty salaries and built libraries. Hundreds of churches of all denominations, major charities, children's homes, historic buildings and art museums benefited from her gifts.

When she died in 1970, her will established the Jessie Ball duPont Religious, Charitable and Educational Fund to continue her philanthropic work. The characteristics and principles that guided her life still guide the Fund today.

Jessie Ball du Pont Fund Jacksonville, Florida The Jessie Ball duPont Fund is a national foundation that makes grants to a defined universe of organizations whose eligibility is determined exclusively by Mrs. duPont's personal philanthropic decisions.

An organization is eligible if it received a gift from Mrs. duPont between January 1, 1960 and December 31, 1964.

Today, there are more than 300 eligible organizations.

focus areas

The Fund organizes its resources around five focus areas:

- Strengthening the Independent Sector
- Building Assets of People, Families and Communities
- Building the Capacity of Eligible Organizations
- Stimulating Community Problem Solving
- * Helping People Hold Their Communities Accountable

Throughout their work, the trustees and staff of the Fund strive to:

- Learn with and from the people they serve;
- Respect the wisdom and creativity of the organizations and communities with whom they work;
- * Engage in thoughtful and disciplined reflection about the decisions they make;
- Maintain the highest ethical standards in all that they do;
- Act with compassion, work for justice, and champion the rights of all people to share in the wealth and health of our nation.

core beliefs

The trustees and staff of the Jessie Ball duPont Fund believe:

- A democratic society that works for all people requires the participation of a strong and organized independent sector.
- Communities are stronger and healthier when:
 - Public, private and philanthropic resources are invested to build the assets of individuals, families and neighborhoods.
 - Citizens, neighborhoods and organizations work together across the boundaries that divide us.
 - They are deliberate about identifying, building and using their philanthropic assets – the time, talent and money of people.
- Citizens have both the right and the responsibility to participate fully in public debate about the distribution of resources, opportunities and assets intended to serve the common good.

letter from the chair and president



Since the Jessie Ball duPont Fund began operations in 1976, its trustees and staff have guided the Fund wisely through economic expansions and contractions. But never in the history of the Fund has the economy been as tumultuous and perilous as that of 2008.

By the end of the year, the value of the Fund's endowment, like those of all endowed institutions, had dropped significantly. (This report does not include the Fund's 2008 audit. It will be posted on our website as soon as it becomes available.) Many of those organizations eligible for support from the Jessie Ball duPont Fund experienced similar declines. Even those organizations without endowments felt the pain of the recession through reduced contributions and increased demand for services.

Despite these challenges, the Jessie Ball duPont Fund is weathering the economic storm.

We began the new year with two newly elected trustees – Mary Lynn Huntley, Esq. and the Rev. Eddie Jones. We hosted two regional meetings, in Richmond, Virginia and Wilmington, Delaware, enabling representatives of eligible organizations to come together and share experiences.

During the year, the Jessie Ball duPont Fund awarded a total of 417 grants, valued at \$14,348,341. In addition, the staff continued oversight of more than 80 multi-year grants awarded in prior years.

Through those grants and other investments in organizations and communities, the Fund expended more than 5% of its value in 2008, exceeding the minimum expenditure the federal government requires of all private foundations. In anticipation of a recessionary economy continuing throughout 2009, the trustees decided to expend a minimum 6% of the Fund's value in 2009. The trustees also committed to fulfill all grant payments made in past years under our competitive grants program.

The Jessie Ball duPont Fund trustees are firm in their commitment to the organizations and the communities in which Mrs. duPont invested so deeply, though the times require us to exercise great discretion. We remain diligent in fulfilling our fiduciary responsibilities so that we may continue to act with compassion, work for justice, and champion the rights of all people to share in the wealth and health of our nation.

the year 2008 will be remembered chiefly for the events of the fourth quarter – the implosion of the housing market, the startling and precipitous decline in the equity markets and the swift contraction in all sectors of the economy. The resulting hardships have left individuals, families and communities struggling through what, for most of them, is the worst economic recession of their lifetimes.

While the economic unraveling touched virtually everyone in the fourth quarter, many Americans have been suffering for much longer. Children, those living in rural communities, those at the lower end of the economic spectrum, those struggling with issues of health or disability – to name a few – have for years seen too few opportunities and too little assistance.

The Jessie Ball duPont Fund supports a wide range of organizations nationally, among them private schools, colleges, universities, churches, and nonprofits ranging from museums and historic organizations to soup kitchens. In recent years, we have sharpened our focus to examine ways that all types of eligible organizations might assist people and communities living outside the economic mainstream.

In this work, our approach is systemic – seeking to encourage and support community infrastructure and networks needed to help local people address their own challenges. That approach is reflected in key accomplishments of 2008.

Mrs. duPont invested deeply in communities that were important to her – among them, the small town of Port St. Joe located in the Florida Panhandle. For the last decade, Port St. Joe has struggled to rebuild its economy following closure of the paper mill that once served as the major employer. Tourism and construction of vacation homes flourished for a while, but that industry deflated long before 2008 – a predictor of the wholesale collapse of Florida's housing markets.

With a population of roughly 4,000, Port St. Joe is home to 19 churches and a garden club eligible for support from the Jessie Ball duPont Fund under the terms of Mrs. duPont's will. Through the years, these eligible organizations have done exceptional work serving the community. We realize,

however, that the challenges confronting the people of Port St. Joe demand services that extend beyond those provided by eligible organizations.

In early 2008, the trustees established the Jessie Ball duPont Port St. Joe Capacity Building Fund, an advised fund at The Community Foundation in Jacksonville. Seeded by a \$500,000 grant from the Jessie Ball duPont Fund, the Port St. Joe fund supports community development efforts and will help nurture the emerging nonprofit sector in the community.

During 2008, the Jessie Ball duPont Port St. Joe Capacity Building Fund awarded two grants:

- •\$113,899 to the Gulf County Community Development Corporation to provide operating support;
- •\$85,000 to the Christian Community Development Fund to support a home-repair program for the elderly and poor and a mini-grant program that serves youth.

In 2006, the Fund convened teams of individuals from five communities in which a large number of eligible organizations are concentrated – Wilmington, Delaware; Richmond and the Northern Neck in Virginia; and Jacksonville and Port St. Joe in Florida – to learn about the benefits and opportunities of community-based initiatives to build the financial assets of low-wealth people. Through that gathering, and subsequent meetings in each of the communities, each "asset team" began to develop its own vision for building a local system that will help low-wealth people climb out of poverty.

In October 2008, we brought the five community teams together again for two days of sharing and learning. The symposium allowed each team an opportunity to report on its work, and offered educational sessions on public policy and advocacy, outcome measurement, leadership development, and engaging younger people to become involved in this work.

In Jacksonville, for example, the team has focused its energy on changing the community's strategy for delivering services to lift families out of poverty. The team is piloting a program that integrates services, empowers individuals and

encourages self-sufficiency while providing intermediate supports. Participating in the effort are 12 community organizations, seven government agencies, and three banks.

In Wilmington, the team has taken a statewide perspective and emphasized an interest in state public policy. In 2008, the team completed a major review of existing resources that identified gaps and opportunities in community services. That review will serve as a foundation for developing future strategies, including the cultivation of grassroots groups with interest in dismantling the policy barriers that keep people impoverished and encouraging financial asset development.

public policy and advocacy

In 2006, the State of Florida launched an ambitious Medicaid reform pilot program designed to use market-based competition to save money and allow beneficiaries more freedom to choose their health coverage plans. Concerned about the affect of these changes on Medicaid beneficiaries – who tend to have more limited skills and

flexibility to navigate the health care system – the Jessie Ball duPont Fund engaged a team of researchers from the Health Policy Institute at Georgetown University to monitor and report on the impact of reform.

From fall 2006 through fall 2008, the researchers published seven briefing papers chronicling the changes brought about by the policy shifts and the changes faced by beneficiaries in adapting to these changes. In general, research findings showed that beneficiaries lacked sufficient access to information needed to make choices among coverage plans, that access to care in many respects was diminished by the reform pilots, and that physicians and other health care providers found the reform system overly burdensome and were less inclined to participate. Moreover, the state did not document financial savings as a result of reform.

These reports, and the webcasts hosted by the Jessie Ball duPont Fund to discuss the research findings, stimulated vigorous debate within the Florida Legislature, where efforts to expand the reform pilot beyond the initial five counties have, to date, stalled.

The research culminated in October 2008 in a statewide conference hosted by the Fund, the Florida Health Policy Center and other funders to discuss the impact of reform and the state's ongoing challenge of delivering quality health care to low-income people. More than 275 individuals, advocates, representatives of the health care industry and members of the Florida Legislature participated.

The debate over Medicaid reform is far from over – the State of Florida's ongoing fiscal crisis creates continuing pressure to find ways to reduce the costs of this and other publically-supported programs. But the Georgetown research supported by the Fund has added immeasurably to the quality of the debate, and given a voice to those who, otherwise, might have had difficulty being heard in the halls of the state capitol.

community safety net funds

By fall 2008, it was becoming apparent that the economic decline would take a severe toll on not only individuals and families, but on nonprofit organizations that work to support people in need. Rising fuel costs and reduced government support had left organizational budgets severely strained over the summer. Circumstances grew worse as endowments declined, contributions plummeted and demand soared through the fall.

In November 2008, we committed to significant investments in funds that would strengthen nonprofit social safety net organizations in multiple communities.

In Jacksonville, the trustees invested \$500,000 to create a Community Safety Net Fund at The Community Foundation in Jacksonville, and offered an additional \$500,000 challenge to contributions from other donors. Within 90 days, the Community Safety Net Fund had taken in almost \$1.5 million and made grants of more than \$1 million to community organizations.

To support the work in other key communities, the trustees established a \$600,000 pool of funding. In 2008, grants

from that pool supported efforts in Wilmington, Delaware, and Richmond, Virginia. (See Notes from the Field – Securing the Safety Net.)

In addition to granting these emergency funds, Jessie Ball duPont Fund staff is actively at work helping communities develop longer-term strategies to address the needs that are expected to continue well into 2009.

looking ahead - developing educational resources

More than 65 of the organizations eligible for support from the Jessie Ball duPont Fund are institutions of higher learning – 37 of them small, private liberal arts colleges. These institutions play a critical role in preparing future generations to be economically productive and civicly engaged.

During 2008, we closely examined a range of opportunities to strengthen these institutions and better position them to attract and retain the students most in need of quality higher education. To that end, the Fund will announce, in 2009, new efforts to encourage and support low-wealth students in pursuing higher education, as well as strategies to help the institutions, themselves, operate smarter and more efficiently in the future.

While this is but a partial review of the Jessie Ball duPont Fund's work in 2008, it illustrates the many ways in which we are working to invest in the organizations and communities that were important to Mrs. duPont.

grantmaking

The Jessie Ball duPont Fund makes grants through multiple grantmaking programs.

The Fund's competitive grantmaking program responds to individual proposals initiated by the eligible organizations, and funds, on a competitive basis, the very best ideas that come forward. Though comparatively few in number, these grants comprise the largest financial investments made by the trustees.

Feasibility grants provide limited, short-term funding to allow eligible organizations to ask and answer fundamental questions before undertaking new work.

Relief grants are made solely at the discretion of the trustees in response to disaster or extraordinary events. The trustees awarded the largest amount of relief grants in the Fund's history during 2008. Only once before – in 2005 in response to Hurricane Katrina – have the trustees awarded more than \$1 million in relief grants during a single year.

Grants made through the Fund's various initiatives are intended to address the diverse and particular needs of the more than 300 eligible organizations that may receive support from the Fund. While the largest number of grants are awarded through these programs, the dollar amount of these grants is comparatively small.

The competitive grantmaking program responds to individual proposals initiated by the eligible organizations. This program funds, on a competitive basis, the very best ideas that come forward. Quality of the idea, relevance to the organization's constituency and community, and consistency with the grantmaking goals of the Fund are the principal criteria that inform the trustees' decisions. The competitive grantmaking program includes many multi-year grants, allowing organizations the opportunity to engage in work over time with the security of financial support.

guidelines for applicants

The Jessie Ball duPont Fund makes grants to a defined universe of eligible organizations. An organization is eligible if it received a contribution from Mrs. duPont between January 1, 1960 and December 31, 1964. Proof of eligibility is determined by examining Mrs. duPont's personal or tax records, or by the applicant presenting written verifiable evidence of having received a contribution during the eligibility period.

Application Process for Competitive Grants

The eligible organization must establish contact with the Fund's program staff before submitting a proposal. The staff will advise the organization on preparation of a written proposal. Once the proposal is submitted, the trustees will review the proposal and invite the organization to answer any questions they might have, or decline the request. The Fund's program staff will contact the eligible organization to discuss the trustees' decision.

When to Apply — After establishing contact with the Fund's program staff, eligible organizations may submit written proposals at any time during the year. The trustees review proposals during trustee conference calls throughout the year and at trustee meetings in February, May, August and November. Those proposals that are invited to the final stage are considered by the trustees during meetings in February, May, August and November.
